SHOW RULES

Each Dealer who signs the bourse application agrees to the following:

- 1.** Dealer hereby indemnifies and **holds harmless both the Sacramento Valley Coin Club and the Four Points by Sheraton** including their officers, directors, associates, employees, agents, representatives, and any legal entities owning, operating or leasing the show area or building housing the show area from any and all claims, liability or causes of action which might arise by reason connected with Dealer's use or rental of exhibit space, including but not limited to any loss, damage, injury, theft, mysterious disappearance of any merchandise, display materials exhibited, equipment, or loss or liability of any kind or sort whatsoever.
- 2. Table Locations:** All efforts will be made to keep returning dealers tables in as close proximity as possible to the table layout of prior SVCC shows. No locations are guaranteed. Dealers agree not to use supplementary tables not paid for in order to create additional display space.
- 3. Dealer Badges** will be **limited** to the following: **two badges per table; four badges per corner group.** (with the exception of spouse or children) **Badges must have persons name and not just company name.** Dealers are responsible for badge wearers. These badge wearers are expected to be **working the table**, not just working the floor as a free visiting dealer. **Dealers not listed on the bourse application will be charged a \$20 fee as a visiting dealer.**
- 4. Dealer tables may not be transferred, sold, leased, or sublet in whole or in part without the written permission of the SVCC Bourse Chair.**
- 5. No dealer may knowingly exhibit or offer for sale any illegal coins, counterfeits, forgeries, unmarked copies or other spurious material.**
- 6.** There will be **no refunds** for show cancellations made 15 days prior to the show. In order to provide a full bourse for the benefit of both dealers and patrons alike, we are forced to institute these policies.
- 7.** Dealer table signs are limited to informational signs (dealer name, location, etc) and signs of a positive nature.
- 8. All Dealers are required to provide a California Resale number. There are NO exceptions.**
