Minutes of 11 May, 1988

Order was called at 7:30 P.M. by President Hank Wavers 48 members and 1 guest were in attendance.

The guest was introduced.

Hank asked if any member was ill or knew if any were ill. None did.

Minutes of the meeting of 27 April were read, corrected, and accepted as corrected.

There was no Treasurer's report presented.

Old Business included: 1. Hank stated that he felt that the club members should make a special effort to keep up attendance during the summer months. He stated that these months traditionally had been ones of low attendance at the meetings. 2. He stated that raffle tickets for the Stanislaus Coin Show raffle are available for those wishing to purchase them. 3. Hank reported that the contract with the BPOE for use of the facility at Florin and Riverside for our coin shows would be signed this week. He stated that the price would be \$1700 for the both days and that there was sufficient electrical energy to support our needs. 4. Tony said that he calculated that we would be no better off financially with the BPOE than with Cal Expo. Ben Gay had the figures that would show that we would make significantly more with this contract. He stated that the price included most of the tables, tablecloths, chairs and other items which had not been covered in the previous contracts. He explained the details to Tony in a separate discussion.

New Business included: 1. Corresponding Secretary John Gomer stated that there was no newsletter for the club in the month of May. He said that there were two primary reasons for this; the first being that he had run out of material to place in the newsletter. The second reason that he did not have a newsletter was that he did not have the time to do the work necessary to complete one. John stated that he would like to hand the newsletter over to a new editor at the end of this year. 2. We have received our ANA Charter renewal for 1988. 3. Hank stated that there are a number of news releases available from the ANA and that they are for everyone's perusal.

A break was called for by Hank at 7:40 P.M.

The meeting was called to order at 8:05 P.M. for the auction. The auction was conducted by Past-President and Auctioneer Emeritus Ben Gay. Junior member Neal Tichner was the runner. A total of \$12.00 was donated to the Club.
