**TABLE ASSIGNMENTS**: As an incentive for returning applications early, the SVCC offers a discounted rate on tables until **August 15, 2019**. Registrations that are returned and paid in full by that time will be included in the initial round of table assignments. After 8/15, the per table cost increases, and bourse location assignments will be made on a first come, first served basis.

#### **SHOW RULES**

Each Dealer who signs the bourse application agrees to the following conditions for all table personnel:

- 1. Dealer hereby indemnifies and holds harmless both the Sacramento Valley Coin Club and the Four Points by Sheraton including their officers, directors, associates, employees, agents, representatives, and any legal entities owning, operating or leasing the show area or building housing the show area from any and all claims, liability or causes of action which might arise by reason connected with Dealer's use or rental of exhibit space. This includes, but is not limited to, any loss, damage, injury, theft, or disappearance of any merchandise, display materials, equipment, or loss or liability of any kind.
- 2. All efforts will be made to keep returning dealers at tables as close in proximity as possible to the table layout of prior SVCC shows. **No locations are guaranteed**. Dealers agree not to use supplementary tables not paid for in order to create additional display space.
- 3. Table credentials will be limited to the following: (2) badges per straight table; (4) badges per corner table (with the exception of spouse or children). Badges must list individual's name. Dealers are responsible for all badged personnel at purchased table(s). Badge wearers are expected to be working the table, rather than only walking the floor to conduct personal business. Dealers not listed on a completed bourse application will be charged a \$20 fee as a visiting dealer.
- **4.** Dealer tables may not be transferred, sold, leased, or sublet in whole or in part without the written permission of the SVCC Bourse Chair.
- **5.** No dealer may knowingly exhibit or offer for sale any illegal coins, counterfeits, forgeries, unmarked copies or other spurious material.
- **6.** There will be <u>no refunds</u> for show cancellations made 15 days prior to the show. Full or partial refunds may be issued in the event of emergency, and will be decided at the discretion of the SVCC Show Coordinator(s).
- **7.** Dealer table signs are limited to informational content (dealer name, location, etc.), or those of a positive nature.
- **8.** The consumption of alcoholic beverages at the show is not allowed, per the SVCC/Four Points contract.
- 9. All Dealers are required to provide a California Resale number. There are NO exceptions.
