We are pleased to invite you to attend our Spring 2023 Coin Show. See attached bourse application. We look forward to hosting you for the event. In addition to filling out and returning your application, please take a look at the following helpful information to plan your weekend with us. **THERE WILL BE NO ACCESS TO THE SHOWROOM ON THURSDAY. DEALER SET-UP BEGINS FRIDAY MORNING AT 9AM. PLEASE NOTE THAT FOR OUR TWO 2023 COIN SHOWS WE ARE CHANGING TO A THREE DAY SHOW FORMAT, FRIDAY-SUNDAY. THERE WILL BE NO TABLE PRICE INCREASE GOING FROM OUR PREVIOUS 2-DAY FORMAT TO A 3-DAY FORMAT.**

**HOTEL:** We have arranged a special room rate of **\$165/night if payment is made by 3/15/2023**, which includes taxes and fees and a free breakfast coupon per person per night. **This \$165 rate is limited to dealers paying the full table rate**, a maximum of 3 nights and one room per Dealer and will apply to the first (15) room nights booked and paid for by our dealers. **PLEASE INCLUDE YOUR ROOM CHARGES WITH YOUR BOURSE TABLE FEES.** Once the discounted block of (15) nights is filled, the hotel's regular room rate will apply. The Four Points offers free parking to all attendees. In addition, the hotel provides free shuttle service to and from Sacramento International Airport for any Dealers who book a room at the property.

**TABLE ASSIGNMENTS:** REGISTRATIONS THAT ARE RETURNED AND PAID IN FULL BY MARCH 15TH, WILL BE INCLUDED IN THE INITIAL TABLE ASSIGNMENTS. After MARCH 15TH location assignments will be made on a first come, first served basis.

**SECURITY:** Security will be provided at all times between Dealer set up on Friday Morning and Dealer tear down on Sunday. We will be providing three Security Guards during our Show.

**MARKETING:** The SVCC will happily provide flyers to Dealers who are willing to distribute show information to their customer base. In addition, a DEALER-SPONSORED DONATION TO OUR HOURLY DOOR PRIZE DRAWING would be greatly appreciated.

### SHOW RULES

Each Dealer who signs the bourse application agrees to the following conditions for all table personnel:

1. Dealer hereby indemnifies and holds harmless both the Sacramento Valley Coin Club and the Four Points by Sheraton - including their officers, directors, associates, employees, agents, representatives, and any legal entities owning, operating or leasing the show area or building housing the show area - from any and all claims, liability or causes of action which might arise by reason connected with Dealer's use or rental of exhibit space. This includes, but is not limited to, any loss, damage, injury, theft, or disappearance of any merchandise, display materials, equipment, or loss or liability of any kind.
2. All efforts will be made to keep returning dealers at tables as close in proximity as possible to the table layout of prior SVCC shows. **No locations are guaranteed.** Dealers agree not to use supplementary tables not paid for in order to create additional display space.
3. Table credentials will be limited to the following: **(2) badges per straight table; (4) badges per corner table** (with the exception of spouse or children). Badges must list individual's name. Dealers are responsible for all badged personnel at purchased table(s). Badge wearers are expected to be working the table, rather than only walking the floor to conduct personal business. **EARLYBIRD/VISITING DEALERS ENTRY-ONE HOUR BEFORE PUBLIC ENTRY (\$25 FEE)**
4. Dealer tables may not be transferred, sold, leased, or sublet in whole or in part without the written permission of the SVCC Bourse Chair.
5. No dealer may knowingly exhibit or offer for sale any illegal coins, counterfeits, forgeries, unmarked copies or other spurious material.
6. There will be **no refunds for Dealer cancellations made within 15 days of the Show.** Full or partial refunds may be issued in the event of an emergency, and will be decided at the discretion of the SVCC Show Coordinator in consultation with the SVCC President.
7. Dealer table signs are limited to informational content (dealer name, location, etc.), or those of a positive nature.
8. The consumption of alcoholic beverages at the show is not allowed, per the SVCC/Four Points contract.
9. All Dealers are required to provide a California Resale number. **There are NO exceptions.**
10. All SVCC Coin Shows will be conducted in compliance with all Orders of the Sacramento County Health Officer. We will advise our Dealers prior to the Show should there be any mask or other requirements for our Show.
